*Approval of Meeting Minutes February 1, 2016*

*Certification of Election - Little Rock Special Election, February 9, 2016*

Provisional Ballot Hearing

No voters were present to contest provision ballot decisions. Three (3) ballots were accepted; eight (8) ballots were rejected.

It was moved by Commissioner Boyle to accept the provisional ballots as determined. It was seconded by Commissioner Gorman. Vote passed by voice vote.

Certification of Election - Jacksonville North Pulaski School District Special Election  
No voters were present to contest provisional ballot decisions.

Mr. Leslie Monaco, a resident of Lonoke County, presented case law to the board today, that gives him question as to whether school districts can hold elections for millage increases at any time other than during annual school elections. He expressed concern as to whether his portion of Lonoke County should be paying the additional tax and if that portion of the county is correctly apportioned.

The final count of provisional ballots was as follows”

Nine (9) yes; Five (5) no

It was moved by Commissioner Gorman to certify the provisional ballots and seconded by Commissioner Boyle. Vote passed by voice vote.

The final results of the Jacksonville North Pulaski School District was as follows:
