*Certification of Ballot Styles for the September 3, 2019 House District 36 Special Primary Runoff*

Commissioner Price moved to certify the ballot styles for the House District 36 Special Primary Election Runoff; seconded by Commissioner McKinnon. Motion passed by voice vote.
