The meeting was called to order by Chairman Kent Walker. A quorum was determined; Chairman Walker and Commissioner Wyrick were present; Commissioner Snider was absent.

APPROVAL OF MEETING MINUTES , JANUARY 27, 2010

Correction: Page 3, OTHER BUSINESS, paragraph 1: The minutes erroneously noted that signs placed at utility and railroad crossings would be moved by "other entities" meaning the Election Commission. It should be stated that the signs would be moved by the State.

Motion to amend "moved by those entities" to "moved by the State" made by Chairman Walker; seconded by Commissioner Wyrick. All in favor; motion carried.

OTHER BUSINESS

The City of Alexander has decided to have a special election with the Primary Election. It is for a detachment from the city in which all residents of the city will vote on. However, the mayor filed the proclamation in the circuit clerk's office instead of the county clerk's office. There will be a separate section on the ballot for this election. It will also appear on the nonpartisan ballot for those voters who do not wish to vote on a party ballot. The filing does not appear to have been voting on by the city council. Chairman Walker asked that the paperwork filed for this election be forwarded to county attorney Karla Burnett for review. The Commission will act upon it after review. Mrs. Allen stated that the mayor of Alexander is in the process of refilling the paperwork. Deadline to submit to our office after filing is Monday, March 15.

Emily Kearns, office intern, was introduced to the commission board. She works part-time, two days a week.
